PROGRESS UPDATE

Block A B & C (Alderney, Breakwater & Caldey Island House)

Replacement ACM to Alderney House & Breakwater House has been completed – and has achieved Building Control approval.

ACM works to Caldey Island House are continuing (expected to be completed within the next 6 weeks – with the scaffolding struck progressively during this time).

Bellway Homes has undertaken further surveys to determine the extent of any additional remediation works to meet the Self Remediation Terms agreed with the Welsh Government – the results of these surveys will be shared shortly.

Block D1 (Davaar House)

Render remediation works to the West Elevation will continue over the coming period and have been progressing well – with the basecoat application now completed.

Scaffold removal to the North Elevation has commenced and this will be shortly followed by the East and South Elevations – as the remaining works are completed.

Residents are advised that the South Elevation stairs and hoist are to remain for the duration of the remaining remediation works (to service the West Elevation rendering) – although there are no current delays to the Spring programme.

Block D2 (Douglas House)

Render remediation works to the North and South Elevations are to continue over the coming period.

Investigations to the bolt-on-balconies are being undertaken to determine whether they need to be removed for access (as there are trapped materials behind the balconies).

Block D3 (Dovercourt House)

Scaffolding to the East and South Elevations continues to be struck (the staircase on the South to remain to provide access for the rendering works to the South Elevation of Block D4).

Remediation works to the North, West and Projection area are to continue over the coming period.

Block D4 (Duncansby House)

Scaffold erection to the South Elevation will commence shortly to facilitate the replacement of the render – this will require the temporary propping of the car park (meaning some spaces will need to be relocated for a short time).

Regen Facades will build a temporary carpark either side of the service road to provide additional spaces for residents – as has been agreed with PPMC and your Property Manager.

Investigations to the bolt-on-balconies are being undertaken to determine whether they need to be removed for access (as there are trapped materials behind the balconies).

Block E (Eddystone House)

The remaining works to Eddystone House are programmed for completion over the course of the next period and the last of the scaffolding removed from the building.

EWS1 certificates shall be provided shortly thereafter.

Block T (Pendeen House)

Façade remediation works to Pendeen House are completed and an EWS1 certificate has been provided to your Property Manager at Ringley.
